Re: Freedom of Information Act Request

Dear Freedom of Information Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Environmental Protection Agency (EPA), 40 C.F.R. Part 2, American Oversight makes the following request for records.

Rep. Elijah Cummings, Ranking Member of the U.S. House of Representatives Committee on Oversight and Government Reform, sent then-EPA Administrator Scott Pruitt a letter regarding the concerning statements former EPA employees have made to that committee with respect to EPA's handling of FOIA requests.¹ Ranking Member Cummings's letter reported that Administrator Pruitt had sought to delay the release of records created during his tenure partly through the implementation of a "first in, first out" FOIA request processing policy which may contradict EPA regulations and Department of Justice guidance.² The letter further reported that EPA documents show that the agency has instituted a new process requiring that FOIA responses undergo a review by senior political appointees before being released.³ Additionally, the letter noted a concerning increase in the proportion of FOIA requests being rejected as not "reasonably described," particularly at EPA headquarters.⁴

American Oversight seeks records to determine whether EPA has improperly instituted FOIA request processing policies with the aim or effect of restricting the release of records responsive to FOIA requests and reducing transparency.

Requested Records


American Oversight requests that EPA produce the following within twenty business days:

All email communications of the EPA employees in the table below with any other EPA personnel (including, but not limited to, individuals with email addresses ending in epa.gov) that contain 1) any of the terms: "keyword," "keywords," "search term," "search terms," "subject," or "subjects" within the same paragraph as 2) any of the terms "reasonably describe," reasonably described," "reasonably describes," "reasonable description," or "21.02".

If EPA has the capability to employ Boolean searches, the appropriate search string to apply would be the following: ("keyword*" OR "search term*" OR "subject") /p ("reasonably describe*" OR "reasonable description" OR "21.02").⁵ If EPA does not have Boolean search capability, we request that EPA run successive searches identifying the most restrictive set of records with any of the terms in category (1) above and then run additional searches across those records to determine which records have terms from category (2) within the same paragraph as terms from category (1).

⁵ Please note, first, American Oversight is here using the asterisk (*) to designate the standard use of "wildcards" in the search for responsive records. For example, a search for "separat*" would return all of the following: separate, separates, separated, separation, etc. If EPA is unable to search for wildcards, please advise so that we may specifically include the variations that we would like searched. Second, American Oversight is using "/p"—meaning "within the same paragraph"—to request records that contain a paragraph with both a search term in the first set of terms above as well as a search term in the second set of terms above. For example, a record that contains a paragraph with both the terms "keywords" and "reasonably described" would be responsive to American Oversight's request. As another example, a record with a paragraph containing both the terms "subject" and "21.02" would also be responsive to American Oversight's request.



Please provide all responsive records from January 20, 2017, to the date the search is conducted.

In addition to the records requested above, we also request records describing the processing of this request, including records sufficient to identify search terms used and locations and custodians searched and any tracking sheets used to track the processing of this request. If EPA uses FOIA questionnaires or certifications completed by individual custodians or components to determine whether they possess responsive materials or to describe how they conducted searches, we also request any such records prepared in connection with the processing of this request.

American Oversight seeks all responsive records regardless of format, medium, or physical characteristics. In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions. Our request includes any attachments to these records. **No category of material should be omitted from search, collection, and production.**

Please search all records regarding agency business. You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.⁶ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; we have a right to records contained in those files even if material has not yet been moved to official systems or if officials have, through negligence or willfulness, failed to meet their obligations.⁷

In addition, please note that in conducting a "reasonable search" as required by law, you must employ the most up-to-date technologies and tools available, in addition to searches by individual custodians likely to have responsive information. Recent technology may have rendered EPA's prior FOIA practices unreasonable. In light of the government-wide requirements to manage information electronically by the end of 2016, it is no longer reasonable to rely exclusively on custodian-driven searches.⁸ Furthermore, agencies that have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies, now maintain emails in a form that is reasonably likely to be more complete than individual custodians' files. For example, a custodian may have deleted a responsive email from his or her email program, but EPA's archiving tools would capture that email under Capstone. Accordingly, American Oversight insist that EPA use the most up-to-date technologies to search for responsive information and take steps to ensure that the most complete repositories of information are searched. We are available to work with you to craft appropriate search terms. However, custodian searches are still required; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.

Under the FOIA Improvement Act of 2016, agencies must adopt a presumption of disclosure, withholding information "only if . . . disclosure would harm an interest protected by an exemption" or "disclosure is prohibited by law."⁹ If it is your position that any portion of the requested records is exempt from disclosure, we request that you provide an index of those documents as required under *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973), *cert. denied*, 415 U.S. 977 (1974). As you are aware, a *Vaughn* index must describe each document claimed as exempt with sufficient specificity "to permit a reasoned judgment as to whether the material is actually exempt under FOIA."¹⁰ Moreover, the *Vaughn* index "must describe *each* document or portion thereof withheld, and for *each* withholding it must discuss the consequences of disclosing the sought-after information."¹¹ Further, "the withholding agency must supply 'a relatively detailed justification, specifically identifying the reasons why a particular exemption is relevant and correlating those claims with the particular part of a withheld document to which they apply."¹²

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document.¹³ Claims of nonsegregability must be made with the same degree of detail as required for claims of exemptions in a *Vaughn* index. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

You should institute a preservation hold on information responsive to this request. American Oversight intends to pursue all legal avenues to enforce its right of access under FOIA, including litigation if necessary. Accordingly, EPA is on notice that litigation is reasonably foreseeable.

To ensure that this request is properly construed, that searches are conducted in an adequate but efficient manner, and that extraneous costs are not incurred, we welcome an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, we can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in electronic format by email or in PDF or TIF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street, NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records, please also provide responsive material on a rolling basis.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and 40 C.F.R. § 2.107(l), American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way.¹⁴ Moreover, the request is primarily and fundamentally for non-commercial purposes.¹⁵

American Oversight requests a waiver of fees because disclosure of the requested information is in the public interest because it is likely to contribute significantly to public understanding of government operations and activities.¹⁶ As discussed above, this request seeks records with the potential to shed light on EPA's processing of FOIA requests. The American public deserves to know if EPA has taken action to restrict the public's access to information about EPA's activities through potentially improper FOIA processing practices and policies. The serious issues Ranking

Member Cummings has raised¹⁷ regarding EPA's potential manipulation of FOIA processing have garnered significant public attention and substantial media coverage.¹⁸

This request is primarily and fundamentally for non-commercial purposes.¹⁹ As a 501(c)(3)nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.²⁰ American Oversight has demonstrated its commitment to the public disclosure of documents and creation of editorial content. For example, after receiving records regarding an ethics waiver received by a senior DOJ attorney,²¹ American Oversight promptly posted the records to its website and published an analysis of what the records reflected about DOJ's process for ethics waivers.²² As another example, American Oversight has a project called "Audit the Wall," where the organization is gathering and analyzing information and commenting on public releases of information related to the administration's proposed construction of a barrier along the U.S.-Mexico border.²³

Accordingly, this request qualifies for a fee waiver.
