Re: Freedom of Information Act Request

Dear FOIA Officers,

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, 7 C.F.R. Part 1, Subpart A, American Oversight makes the following request for records.

U.S. Department of Agriculture (USDA) Secretary Sonny Perdue entered office with a lengthy ethics recusal letter and an extensive financial disclosure report, which detailed a web of Georgia-based entities that created recusal obligations for the Secretary.¹ Mr. Perdue's history in Georgia government, however, indicates a high tolerance for conflicts of interest: as governor, Mr. Perdue continued to own or help run four farming-related family businesses.² Furthermore, in October 2018, *The Atlanta Journal-Constitution*, using calendars obtained by American Oversight through FOIA, reported that Secretary Perdue "has been a frequent presence in Georgia" during his time serving in the Trump Administration.³

American Oversight seeks records to shed light on Secretary Perdue's actions and communications during his tenure as Secretary of Agriculture to improve the public's understanding of how Perdue has impacted agriculture policy, including whether and to what extent he has privileged his Georgia or business ties.

Requested Records

American Oversight requests that USDA produce the following records within twenty business days:

All email communications (including email messages, email attachments, and calendar invitations) between (1) Rural Development Georgia State Director Joyce White or Farm Service Agency Georgia Executive Director Tas Smith and (2) any of the following individuals or entities:

- i. Any personal email accounts attributed to Secretary Sonny Perdue;
- ii. Anyone communicating from an email address ending in perdue.pro;
- iii. Perdue, Inc., including anyone with an email address ending in perdueinc.com;
- iv. Perdue Partners, including anyone with an email address ending in perduepartners.com;
- v. Perdue Management Holdings LLC;
- vi. Perdue Business Holdings, Inc., including Robert Tuggle and anyone with an email address ending in dltj.com;
- vii. Senator David Perdue or anyone from his office, including the Senator and anyone with an email ending in perdue.senate.gov or perduesenate.com; or
- viii. AGrowStar, including anyone with an email address ending in agrowstar.com.

Please provide all responsive records from April 24, 2017, through the date the search is conducted.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a) (4) (A) (iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."⁴ The public has a significant interest in what outside or personal interests might influence USDA officials' decision-making on policy matters of interest to the public, and how officials approach ethics requirements.⁵ Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including whether Secretary Perdue has followed his ethics agreement to avoid conflicts of interest and whether he has been engaging with Georgia ties using personal email. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.⁶ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁷

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.⁸ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;⁹ posting records received as part of American Oversight's "Audit the Wall" project

to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;¹⁰ posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;¹¹ posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;¹² and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.¹³

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files,

email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.¹⁴ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹⁵

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,¹⁶ and many agencies have adopted the National Archives and Records Administration (NARA)
 Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
