Re: Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Department of State (State), 22 C.F.R. Part 171, American Oversight makes the following request for records.

United States Special Representative for Iran, and former Director of Policy Planning, Brian Hook has been an influential member of State's political leadership since the beginning of the Trump administration. Mr. Hook has become involved in several controversies, including accusations that he has mistreated career staffers, a possible finding by the Inspector General that he was involved in retaliation against career officials for their perceived lack of political loyalty, and his participation in Jared Kushner's irregular diplomatic efforts in the Middle East.

American Oversight seeks records to shed light on Mr. Hook's actions and communications during his tenure in high-level roles at State in order to provide the public with information about Mr. Hook's priorities and any external influences on his actions. This is particularly important given Mr. Hook's apparently rising influence within the administration.

## Requested Records

American Oversight requests that State produce the following records within twenty business days:

All email communications (including email messages, email attachments, and calendar invitations) <u>sent</u> by Brian Hook to any email address ending in .com, .net, .org, .edu, .il, .ae, or .sa (including complete email chains).

In an effort to accommodate State and reduce the number of responsive records to be processed and produced, American Oversight has limited its request to emails sent by Mr. Hook. To be clear, American Oversight still requests that complete email chains be produced, displaying both the responsive sent messages and the prior received messages in each email chain. This means, for example, that both Mr. Hook's response to an email from a .com domain and the initial received message are responsive to this request.

Please provide all responsive records from March 1, 2018, through the date the search is conducted.

#### Fee Waiver Request

In accordance with 5 U.S.C. § 552(a) (4) (A) (iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."<sup>5</sup> The public has a significant interest in what outside or personal interests might influence a high-ranking official's decision-making on policy matters of significant interest to the public. Mr. Hook has held influential foreign policy positions, and his priorities and actions in those roles are a matter of significant public concern. Additionally, the public has an interest in knowing whether Mr. Hook has communicated with external, non-government entities

about matters of significant controversy, including our nation's Iran policy, the State Department's reported retaliation against career officials, or Jared Kushner's controversial diplomatic efforts. Records with the potential to shed light on these matters would contribute significantly to public understanding of operations of the federal government, including whether Mr. Hook has followed been unduly influenced by external entities and whose outside views and interests he has prioritized in his high-ranking roles. The records American Oversight has requested will achieve these aims by revealing those external entities Mr. Hook has engaged with in his communications, and by showing which entities he prioritizes in his communications. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website. Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers; Posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed

construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>11</sup> posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;<sup>12</sup> posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;<sup>13</sup> and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.<sup>14</sup>

Accordingly, American Oversight qualifies for a fee waiver.

# Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records.
- Our request for records includes any attachments to those records or other
  materials enclosed with those records when they were previously transmitted. To
  the extent that an email is responsive to our request, our request includes all prior
  messages sent or received in that email chain, as well as any attachments to the
  email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal

Records Act and FOIA.<sup>15</sup> It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.<sup>16</sup>

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically, and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
