Re: Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Department of Homeland Security (DHS), 6 C.F.R. Part 5, American Oversight makes the following request for records.

From September 1, 2018 to Aug. 22, 2019, 758 migrants were infected with mumps after being exposed to the disease while held in federal detention centers.¹ News outlets also have reported that the United States will not provide flu vaccines to migrant families held at federal holding facilities and detention centers ahead of this year's flu season, despite flu-related deaths of at least three children held at detention centers in recent years.²

In the wake of these events, medical and public health experts have cautioned that “the Department of Homeland Security and Department of Health and Human Services may not be following best practices with respect to screening, treatment, isolation, and prevention of influenza,” and that “[p]oor conditions at the facilities may be amplifying

the spread of influenza and other infectious diseases, increasing health risks to children.”³ Similar views have been expressed by Texas health officials, who noted in a slideshow presentation that detention facility staff are “not trained to recognize infectious diseases,” have “[n]o experience with notifiable conditions,” and a “[h]esitance to involve public health.”⁴

American Oversight seeks records with the potential to shed light on the current policies and protocols regarding infectious disease prevention, diagnosis, treatment, and control at facilities housing or detaining migrants, and the efficacy of these policies and protocols.

Requested Records

American Oversight requests that the U.S. Immigration and Customs Enforcement (ICE) to produce the following records within twenty business days:

1. Records sufficient to show the total number and percentage of detainees who received vaccinations against the infectious diseases listed below before or during their detainment at the ICE facilities listed below, from January 20, 2017, through the date of the search.

2. Records sufficient to show the numbers of suspected and confirmed cases of any of the infectious diseases listed below, among detainees held for any length of time at the ICE facilities listed below, from January 20, 2017, through the date of the search.

3. Records sufficient to show the number of deaths attributed to any of the infectious diseases listed below, among detainees held for any length of time at ICE facilities listed below, from January 20, 2017, through the date of the search.

American Oversight would consider as responsive to this request any vaccination, case, or death reports or records of other similar communications sent by the listed ICE facilities to the ICE Health Service Corps (IHSC), the U.S. Centers for Disease Control & Prevention (CDC), and/or state or local health departments during the identified time periods. Other forms of responsive records may include spreadsheets or results from queries of relevant databases. American Oversight does not object to the redaction of names or other personally identifying information from records responsive to this request.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency’s regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is “in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government.”⁵ The public has a significant interest in whether and the extent to which federal officials and contractors are taking necessary and appropriate steps to prevent, screen, diagnose, isolate, and treat infectious disease outbreaks among adults and children in their custody.⁶ Records with the potential to shed light on this life and death matter would contribute significantly to public understanding of operations of the federal government, including one of its most important responsibilities—the safety and care of the individuals it has detained and deprived of liberty. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public’s

understanding of the government’s activities would be enhanced through American Oversight’s analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.⁷ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight’s financial interest. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁸

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.⁹ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department’s process for issuing such waivers;¹⁰ posting records received as part of American Oversight’s “Audit the Wall” project to gather and analyze information related to the administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;¹¹ posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;¹² posting records and analysis relating to the

federal government's efforts to sell nuclear technology to Saudi Arabia;¹³ and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.¹⁴

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.¹⁵ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹⁶
- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,¹⁷ and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency’s archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please
