Re: Public Records Request

Dear Public Records Officer:

Pursuant to Florida's public records laws, as codified at Fla. Stat. Chapter 119, American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Florida Department of State promptly produce the following:

- 1. All e-mail communications (including complete email chains and email attachments) <u>sent</u> by any of the Department of State officials listed below <u>including</u> the following terms:
 - "ERIC"1
 - "Electronic Registration Information Center"
- 2. All e-mail communications (including complete email chains and email attachments) <u>sent</u> by any of the Department of State officials listed below to any email addresses ending in "@ericstates.org".

Department of State officials:

- a. Maria Matthews, Director, Division of Elections
- b. Toshia Brown, Chief, Bureau of Voter Registration Services
- c. Amber Marconnet, Senior Manager, Bureau of Voter Registration Services

With regard to your search for responsive email communications, American Oversight agrees that the search may be limited to emails <u>sent</u> by Department of State officials in an effort to accommodate the department and reduce the number of potentially responsive

records. Despite this search accommodation, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. Furthermore, our request includes any attachments to these records.

Please provide all responsive records from August 1, 2019, to the date of the search.

Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

In addition, American Oversight insists that you use the most up-to-date technologies to search for responsive information and take steps to ensure that the most complete repositories of information are searched. American Oversight is available to work with you to craft appropriate search terms. However, custodian searches are still required; your office may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

Please take appropriate steps to ensure that records responsive to this request are not deleted by your office before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

To ensure that this request is properly construed, that searches are conducted in an adequate but efficient manner, and that extraneous costs are not incurred, American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, we can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in electronic format by email or in PDF or TIF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Conclusion

American Oversight is a 501(c)(3) nonprofit with the mission to promote transparency in government, to educate the public about government activities, and to ensure the accountability of
