Re: Freedom of Information Act Request

Dear Ms. Pavlik-Kennan:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Department of Homeland Security (DHS), 6 C.F.R. Part 5, American Oversight makes the following request for records.

Thomas Blank, who was the former Chief of Staff to former Acting Immigration and Customs Enforcement (ICE) Director Thomas Homan, worked for years in government relations in the homeland security space, including at Wexler & Walker, where he lobbied for DHS contractor Taser International, now known as Axon.¹

American Oversight seeks the following records in an effort to shed light on whether senior ICE officials have been influenced by industry interests, including those of former employers.

Requested Records

American Oversight requests that ICE produce the following within twenty business days:

1. All email communications (including emails, email attachments, and calendar invitations) of Former Acting ICE Director, Thomas Homan, his former Chief of Staff, Thomas Blank, or anyone communicating on Former Acting Director Homan's behalf, such as a scheduler or assistant, and any of the following:

- A) Any employee or representative of Axon Enterprise, Inc., formerly known as Taser International (including, but not limited to, individuals with email addresses ending in @axon.com or @taser.com);
- B) Any employee or representative of Wexler & Walker (including, but not limited to, individuals with email addresses ending in @wexlerwalker.com);
- C) Any employee or representative of Gephardt Government Affairs (including, but not limited to, individuals with email addresses ending in @gephardtdc.com)

Please provide all responsive records from January 30, 2017, through June 30, 2019.

- 2. All email communications (including emails, email attachments, and calendar invitations) of Former Acting ICE Director, Thomas Homan, his former Chief of Staff, Thomas Blank, or anyone communicating on Former Acting Director Homan's behalf, such as a scheduler or assistant, containing any of the following terms:
 - a. Taser
 - b. electroshock
 - c. electro-shock
 - d. "stun gun"
 - e. "electric weapon"
 - f. CED
 - g. "conducted energy"
 - h. ECW
 - i. "electronic control"
 - j. Axon
 - k. Wexler
 - l. Walker
 - m. "less-lethal"
 - n. "less lethal"
 - o. "pepper spray"
 - p. oleoresin
 - q. capsicum
 - r. "OC Spray"
 - s. "tear gas"
 - t. "compressed air"
 - u. "bean bag"

Please provide all responsive records from January 30, 2017, through June 30, 2019.

Please <u>exclude</u> news clips generated from non-governmental services and emails distributed to a wide listserv of twenty or more email addresses. A news clips email that is forwarded by an individual to one of the identified individuals with any additional message *should* be considered responsive.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a) (4) (A) (iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government." The public has a significant interest in what influence personal or professional connections between senior DHS officials and DHS contractors or those lobbying on their behalf may exert over public policy. Records with the potential to shed light on this question would contribute significantly to public understanding of operations of the federal government, including whether these relationships continued to exert influence after said officials assumed public office. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.³ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁴

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.⁵ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;⁶ posting records received as part of American

Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁷ posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;⁸ posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;⁹ and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.¹⁰

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside

of official files are subject to the Federal Records Act and FOIA.¹¹ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹²

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,¹³ and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

Conclusion

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset,

We share a common mission to promote transparency in government. American Oversight looks forward to working with your agency on this request.
