Re: Right-to-Know/Public Records Request

Dear Mr. Formella:

Pursuant to the New Hampshire Constitution Part I, Article 8, and New Hampshire's Right-to-Know Law, as codified at RSA Chapter 91-A, I, Louise Spencer (a citizen of New Hampshire), make the following request for records.

Requested Records

I request that the Office of the Governor produce the following within five business days:

1. All communications (including emails, email attachments, text messages, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), calendar invitations, letters, memoranda, or other communications) between Governor Chris Sununu—or anyone communicating on his behalf, such as a scheduler or assistant—and any of the following individuals or entities:
 - a. Scott Walker
 - b. Adam Kincaid
 - c. Guy Harrison
 - d. Gail Gitcho
 - e. Lauren Bryan
 - f. Jason Torchinsky
 - g. Dale Oldham
 - h. Anyone communicating on behalf of the National Republican Redistricting Trust (NRRT) (thenrrt.org)
 - i. Anyone communicating on behalf of the American Legislative Exchange Council (ALEC) (alec.org)
 - j. Anyone communicating on behalf of the Republican State Leadership Committee (RSLC) (rslc.gop)

Please provide all responsive records from August 1, 2019, through August 30, 2019.

2. All communications (including emails, email attachments, text messages, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), calendar invitations, letters, memoranda, or other communications) between (a) the individuals employed by the Office of the Governor and/or working on behalf of the

Governor (as volunteers or otherwise), listed below in Column A, and (b) the individuals listed below in Column B:

Pursuant to RSA 91-A:4(IV), if you are unable to produce the requested records within five business days, please provide written acknowledgement of this request and a statement of the time reasonably necessary to determine whether the request will be granted or denied.

Costs and Fees

Pursuant to RSA 91-A:4(IV), I ask that any charges in connection with processing this request for records not exceed the actual cost of providing the copies.

Please notify my counsel of any anticipated costs in excess of \$100 prior to incurring such costs. In addition, should any fees otherwise established by law apply to this request for records, please notify my counsel in advance. Contact information for my counsel is provided at the end of this letter.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, I provide the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, as the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind.

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event that any responsive records are exempt from disclosure, in whole or in part, please state specifically the justification for the withholding with reference to the applicable section of the Right-to-Know law or other legal authority that exempts the information from disclosure.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

Conclusion

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records in response to this request, please do not hesitate to contact my counsel to discuss this request. We welcome an opportunity to discuss this request with you before you undertake your search or incur duplication costs. By working together at the outset, we can decrease the likelihood of costly and time-consuming litigation in the future.
