Re: Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, American Oversight makes the following request for records.

The Washington Post recently reported on new Trump campaign donors, identifying at least 220 donors who have either never made previous political contributions or did not support Trump in 2016.¹ Some of these political newcomers include the Wilks brothers, billionaires who made their fortune in fracking, and have only sparingly donated to select campaigns in the past. According to reports, Dan and Farris Wilks have already donated over \$100,000 to the Trump re-election campaign.

American Oversight seeks records to shed light on whether and to what extent political donors are influencing agency policy.

Requested Records

American Oversight requests that your agency produce the following records within twenty business days:

1. All email communications (including emails, email attachments, complete email chains, calendar invitations, and attachments thereto) sent or received by the specified individuals at your agency regarding Dan Wilks, Farris Wilks, and/or companies and foundations Wilks Brothers LLC (wilksbrothers.com), Wilks Brothers Inc., Wilks Ranch Brokers LLC (wilksranchbrokers.com), Thirteen Foundation, and Heavenly Father’s Foundation, including but not limited to any email communications between agency officials and any staff of the Executive Office of the President (including anyone on White House staff or in the Office of the Vice President) regarding Dan Wilks and/or Farris Wilks.

2. All email communications (including emails, email attachments, complete email chains, calendar invitations, and attachments thereto) between (1) the specified individuals at your agency and (2) Dan Wilks, Farris Wilks (including but not limited to the email addresses dwilks@ciscohigh-lift.com and dwilks@cs.com), or anyone communicating on their behalf or on behalf of their companies and foundations Wilks Brothers LLC (wilksbrothers.com), Wilks Brothers Inc., Wilks Ranch Brokers LLC (wilksranchbrokers.com), Thirteen Foundation, and Heavenly Father’s Foundation.

Specified Custodians

- i. Dan Brouillette, Secretary of Energy, and anyone communicating on his behalf, such as assistants and schedulers
- ii. Rick Perry, former Secretary of Energy, and anyone communicating on his behalf, such as assistants and schedulers

- iv. Bruce J. Walker, Assistant Secretary of Energy, Fossil Energy
- v. Anyone serving in the capacity of Chief of Staff

Please provide all responsive records from March 1, 2019, to the date the search is conducted.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency’s regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is “in the public interest because it is likely to contribute significantly to

public understanding of operations or activities of the government.”² The public has a significant interest in communications with or discussions regarding big donors among agency employees and White House staff. Records with the potential to shed light on this issue would contribute significantly to public understanding of operations of the federal government, including whether and to what extent campaign donors are influencing agency policy. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public’s understanding of the government’s activities would be enhanced through American Oversight’s analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.³ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight’s financial interest. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁴

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.⁵ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department’s process for issuing such waivers;⁶ posting records received as part of American Oversight’s “Audit the Wall” project to gather and analyze information related to the administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁷ posting

records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;⁸ posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;⁹ and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.¹⁰

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal

Records Act and FOIA.¹¹ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹²

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,¹³ and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
