## Re: Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, 49 C.F.R. Part 7, American Oversight makes the following request for records.

The Trump administration's Environmental Protection Agency (EPA) and National Highway Traffic Safety Administration (NHTSA) recently finished rewriting the regulations that govern greenhouse gas emissions and fuel efficiency standards for vehicles nationwide.<sup>1</sup> The rewrite rolls back the standards put in place by the Obama administration, implementing just a 1.5% increase—rather than 5%—in carbon dioxide emissions standards for personal vehicles. The administration claims that the "rule supports our economy, and the safety of American families."<sup>2</sup> But critics on the Hill,<sup>3</sup> at EPA,<sup>4</sup> and amongst the scientific community,<sup>5</sup> have raised concerns that the new rule

would increase the number of premature deaths due to air pollution, raise the price of gasoline, and harm the environment.

American Oversight submits this request to shed light on NHTSA's role in the rewrite of the emissions and fuel efficiencies regulations.

### Requested Records

American Oversight requests that NHTSA produce the following records within twenty business days:

1. All email communications (including email messages, complete email chains, email attachments, and calendar invitations) <u>sent</u> by Jeffrey Rosen, former Deputy Secretary of Transportation, to any email address ending in .com, .net, .org, .edu, .mail, or .eop.gov, containing any key term listed below.

- i. Phantom
- ii. Tailpipe\*
- iv. Death\*
- v. Fatalit\*
- vi. Honda
- vii. "Safer affordable"
- viii. CAFE/GHG
- ix. California

Please provide all responsive records from January 20, 2017, through May 23, 2019.

2. All email communications (including email messages, complete email chains, email attachments, and calendar invitations) <u>sent</u> by Jeffrey Rosen, former Deputy Secretary of Transportation, using the term "phantom."<sup>6</sup>

Please provide all responsive records from October 20, 2018, through November 20, 2018.

In an effort to accommodate your agency and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited its request to emails <u>sent</u> by Mr. Rosen. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both Mr. Rosen's response to an email containing a key term and the initial received message are responsive to this request and should be produced. This request includes all prior messages (whether incoming or outgoing) reflected in the responsive correspondence and any attachments thereto.

Please note that American Oversight is using the asterisk (\*) to designate the standard use of "wildcards" in the search for responsive records. For example, a search for "separat\*" would return all of the following: separate, separates, separated, separation, etc. If your agency is unable to search for wildcards, please advise so that we may specifically include the variations that we would like searched.

## Fee Waiver Request

In accordance with 5 U.S.C. § 552(a) (4) (A) (iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."<sup>7</sup> The public has a significant interest in the federal government's regulation of the safety, fuel economy, and emissions of passenger vehicles. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including shedding light on how your agency handled major errors in drafts of the SAFE vehicle rule.<sup>8</sup> American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.<sup>9</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the

information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>10</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.<sup>11</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;<sup>12</sup> posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>13</sup> posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;<sup>14</sup> posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;<sup>15</sup> and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and

make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.<sup>16</sup>

Accordingly, American Oversight qualifies for a fee waiver.

### Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless
  of format, medium, or physical characteristics. For instance, since the request
  seeks "communications," please search all locations likely to contain
  communications, including relevant hard-copy files, correspondence files,
  appropriate locations on hard drives and shared drives, emails, text messages or
  other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter
  direct messages), voicemail messages, instant messaging systems such as Lync or
  ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal

Records Act and FOIA.<sup>17</sup> It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.<sup>18</sup>

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,<sup>19</sup> and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are
  not deleted by the agency before the completion of processing for this request. If
  records potentially responsive to this request are likely to be located on systems
  where they are subject to potential deletion, including on a scheduled basis, please
  take steps to prevent that deletion, including, as appropriate, by instituting a
  litigation hold on those records.
