Re: Illinois Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Illinois Freedom of Information Act (FOIA), 5 ILCS § 140, American Oversight makes the following request for records.

The Trump administration has deployed federal law enforcement officers in problematic ways in recent months, including through "Operation Legend," a high-profile effort that the U.S. Department of Justice (DOJ) has asserted is aimed at reducing violent crime in key cities.¹ However, DOJ has expanded the operation to cities in states that may be pivotal in the coming presidential election, raising fears that the deployments are politically motivated.² In September, Attorney General Bill Barr claimed that the operation had resulted in 500 arrests in Chicago, and credited it for a drop in the city's homicide rate.³ American Oversight seeks records with the potential to shed light on state and local officials' communications with the U.S. Department of Justice and Department of Homeland Security in light of these deployments and other federal actions.

Requested Records

American Oversight requests that your office produce the following records within five business days:

All email communications (including emails and email attachments) <u>sent</u> by 1) Governor Jay Robert ("J.B") Pritzker, Chief of Staff Anne Caprara, or Deputy Chief of Staff for Federal Affairs Pat Collier, to 2) anyone communicating from an email address ending in usdoj.gov, fbi.gov, or dhs.gov.

Please provide all responsive records from July 15, 2020, through the date the search is conducted.

In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited its request to emails <u>sent</u> by the above officials. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both Governor Pritzker's response to an email from an usdoj.gov email address and the initial received message are responsive to this request and should be produced.

Fee Waiver Request

In accordance with 5 ILCS § 140/6(c), American Oversight requests a waiver of fees associated with processing this request for records. A waiver of fees for this request "is in the public interest" because "the principal purpose of the request is to access and disseminate information regarding the health, safety and welfare or the legal rights of the general public and is not for the principal purpose of personal or commercial benefit."⁴

The public has a significant interest in Illinois officials' communications with the federal government in light of the major deployments of federal law enforcement officers to localities like Chicago. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the interactions between state, local, and federal government, including whether the federal government is inappropriately using law enforcement officers over the objections of local leaders. American Oversight is a 501(c)(3) nonprofit organization committed to transparency and makes the responses agencies provide to FOIA requests publicly available. The public's understanding of the government's activities related to public health, safety, welfare, and legal rights would be enhanced through American Oversight's analysis and publication of these records.

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses

posted to its website.⁶ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization's State Accountability Project covering voting rights issues in various states;⁷ posting records and analysis of federal and state governments' responses to the Coronavirus pandemic;⁸ posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the Trump administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁹ and the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers.¹⁰

Moreover, this request is not made for a personal or commercial benefit.¹¹ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the

release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter. 12

Accordingly, American Oversight qualifies for a fee waiver.

In addition, because American Oversight is a 501(c)(3) nonprofit organization and the principal purpose of this request is "to access and disseminate information concerning news and current or passing events" and for "public research or education," American Oversight should not be considered a "recurrent requester," nor should this request be treated as a "voluminous request" under the Illinois FOIA. See 5 ILCS § 140/2(g)-(h).

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted.
 To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.¹³ If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located

on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
