Re: Freedom of Information Act Request

Dear FOIA Officers:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, American Oversight makes the following request for records.



In the midst of a coronavirus outbreak, the Trump administration has imposed drastic restrictions on immigration.¹ The government has rapidly deported hundreds of unaccompanied minors, sometimes within hours of their arrival to the United States.² Many of these children have no safe place to return in their home countries.³ In the past, the government has provided shelter, education, and medical care, as well as an opportunity to claim asylum.⁴ As such, this represents a reversal of years of established practice.⁵

American Oversight seeks records with the potential to shed light on how the Trump administration is handling deportations of unaccompanied minors in the midst of a public health crisis.

Requested Records

American Oversight requests that your agency produce the following records within twenty business days:

Any records reflecting any directive, order, decision, protocols, or guidance regarding the deportation or removal of unaccompanied minors.

This includes but is not limited to any directive, order, decision, protocols, or guidance which addresses the following issues:

- i. Whether these minors have any family residing within the United States who could serve as guardians or sponsors
- ii. Whether these minors will receive any food, medical treatment, or shelter before their deportation or removal
- iii. Whether these minors will have the opportunity to make an asylum claim before their deportation or removal
- iv. Whether these minors have a safe place to be sent outside of the United States

American Oversight believes your agency is best positioned to determine where responsive records may reside. However, we request that at a minimum, you search:

Department of Homeland Security

1. Immediate Office of the Secretary
2. Office of the General Counsel
3. Office of Strategy, Policy, and Plans
4. Office for Civil Rights and Civil Liberties

Citizenship and Immigration Services

1. Immediate Office of the Director
2. Office of Chief Counsel

4. Refugee, Asylum, and International Relations Directorate

Customs and Border Protection

1. Immediate Office of the Commissioner
2. Office of the Chief Counsel
3. Immediate Office of the Executive Assistant Commissioner for Field Operations

Immigration and Customs Enforcement

1. Immediate Office of the Director
2. Office of the Principal Legal Advisor

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government

procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is “in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government.”⁶ The public has a significant interest in the treatment of unaccompanied minors, as demonstrated by extensive media coverage on this topic.⁷ Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including how the Trump administration is handling deportations in the midst of a public health crisis. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public’s understanding of the government’s activities would be enhanced through American Oversight’s analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.⁸ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight’s financial interest. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁹

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.¹⁰ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the Trump Administration’s contacts with Ukraine and analyses of those contacts;¹¹ posting records and editorial content about the federal government’s response to the Coronavirus pandemic;¹² posting records received as part of American Oversight’s

“Audit the Wall” project to gather and analyze information related to the administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;¹³ the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department’s process for issuing such waivers;¹⁴ and posting records and analysis of federal officials’ use of taxpayer dollars to charter private aircraft or use government planes for unofficial business.¹⁵

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all

prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.¹⁶ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹⁷
- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,¹⁸ and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located

on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
