### **Re: Access to Public Records Act Request**

Dear Public Records Officer:

Pursuant to the Access to Public Records Act ("APRA"), R.I. Gen. Laws, Tit. 38, Ch. 2, American Oversight makes the following request for records.

On January 6, 2021, Rhode Island Rep. Justin Price participated in the rally outside of the Capitol that grew into a riotous crowd and stormed the building. He has stated that he did not commit any illegal actions, and that he was not among the rioters who stormed the Capitol. Since then, the Rhode Island Treasurer has called on him to resign.<sup>1</sup>

American Oversight seeks records with the potential to shed light on Rhode Island Rep. Justin Price's potential participation, knowledge of, and involvement in trying to overthrow the 2020 election.

# **Requested Records**

American Oversight requests that the Rhode Island General Assembly produce the following records within ten business days:

1) All email communications (including email messages, complete email chains, email attachments, calendar invitations, and calendar attachments) <u>sent</u> by Rep. Justin Price containing any of the key terms listed below.

Please provide all responsive records from January 1, 2021, through January 14, 2021.

In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited Item 1 of its request to communications <u>sent</u> by Rep. Price. This means, for example both Rep. Price's response to an email containing one of the listed key terms and the initial received message are responsive to this request and should be produced.

2) All text message threads/conversations, or messages on similar applications (such as Signal, WhatsApp, or Facebook Messenger) sent to or received by Rep. Justin Price containing any of the key terms listed in Item 1 above.

Please provide all responsive records from January 1, 2021, through January 14, 2021.

American Oversight requests complete text threads/conversations. This means, for example, if Rep. Price sent or received a text message containing any of the key terms listed above, the complete text thread/conversation for the timeframe listed above should be produced, and not just the message containing the key term.

3) Records reflecting any and all expenditures of Rep. Justin Price's trip on or about January 6, 2021 to Washington, D.C., including, but not limited to, records of any reimbursements submitted by or on behalf of Rep. Price.

Responsive records would include, but are not limited to, hotel or other lodging invoices or receipts; legislature-issued charge card or travel card reports; receipts from airlines, rental car, or other transportation companies; records reflecting the cost of government transportation; receipts or other records reflecting the cost of meals or refreshments; or records reflecting per diem payments.

Please provide all responsive records from January 1, 2021, through the date a search is conducted.

### Fee Waiver Request

American Oversight respectfully requests that your office consider waiving any fees permitted under R.I. Gen. Laws § 38-2-4(a)-(b) associated with processing this request for records. To the extent your office elects to charge for copies or for the search and retrieval of the requested records, we request that you provide a fee estimate before incurring such costs, as well as a detailed itemization of the costs to be charged for search and retrieval, pursuant to R.I. Gen. Laws § 38-2-4(c)-(d).

Disclosure of the requested information "is in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government and is not primarily in the commercial interest of the requester."<sup>2</sup> The public has a significant interest in the actions Rep. Justin Price may have taken in response to the 2020 election and especially his actions at the January 6 rally in Washington, D.C.<sup>3</sup> Records with the potential to shed light on these issues would contribute significantly to public understanding of operations of the government, including whether Price sought reimbursements for his travel to the rally, or whether he used his official email account to coordinate with other rally attendees. American Oversight is committed to transparency and makes the responses agencies provide to public records requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.<sup>4</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>5</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.<sup>6</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization's investigations into misconduct and corruption in state governments;<sup>7</sup> posting records and analysis of federal and state governments' responses to the Coronavirus pandemic;<sup>8</sup> posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the Trump administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>9</sup> and the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers.<sup>10</sup>

Accordingly, American Oversight qualifies for a fee waiver.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.<sup>11</sup> If the request is denied in whole, please state the specific reasons for the denial, including why it is not reasonable to segregate portions of the record for release.<sup>12</sup> Furthermore, if the request is denied in whole or in part, please provide the specific reasons for the denial in writing.<sup>13</sup>
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
