Re: Open Records Request

Dear Open Record Office Thomason:

Pursuant to the Georgia Open Records Law (O.C.G.A. §§ 50-18-70 et seq.), American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Pickens County Board of Commissioners and Board of Elections and Registration produce the following within three business days:

1. All email communications (including emails, complete email chains, email attachments, calendar invitations, and calendar attachments) <u>sent</u> by any of the Pickens County Board of Commissioners or Board of Elections and Registration members listed below concerning any proposed or implemented changes to the authority, composition, or member selection method of the Pickens County Board of Elections and Registration (including, but not limited to, any communications concerning HB 682 or HB 683).

Pickens County Board of Commissioners:

Pickens County Board of Elections and Registration:

In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited <u>item 1</u> of its request to emails <u>sent</u> by the listed custodians. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for



example, that both Commissioner Barnes' response to an email concerning changes to the authority, composition, or member selection method of the Pickens County Board of Elections and Registration and the initial received message are responsive to this request and should be produced.

2. All email communications (including emails, complete email chains, email attachments, calendar invitations, and calendar attachments) <u>between</u> (a) any of the Pickens County Board of Commissioners or Board of Elections and Registration members listed above and (b) any of the external parties listed below.

For item 2 of this request, please note that American Oversight does not seek, and that the request specifically excludes, the initial mailing of news clips, press releases, or other mass-distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if Commissioner Barnes received a press release from Rep. Jasperse, that initial email would not be responsive to this request. However, if Commissioner Barnes forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

For both items of this request, please provide all responsive records from November 3, 2020, to the date the request is received by your office.

Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Open Records Act.¹
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your agency can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Conclusion

American Oversight is a 501(c)(3) nonprofit with the mission to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public
