Re: Public Records Request

Dear Senate Public Records Attorney & Senator Fann:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Office of Senator Fann promptly produce the following records:

All email communications (including complete email chains and email attachments) received by Senator Fann from ALEC Connect¹ (including, but not limited to, all emails received from any email address ending in candoris.com).

Email messages sent via ALEC Connect may be truncated when displayed on Senator Fann's email client. If this is the case, it may be necessary to log into ALEC Connect to identify complete copies of the responsive records.

Please do not limit your search to government-issued email accounts. We request the production of any emails, whether on government-issued or personal accounts, received from ALEC Connect.

Please provide all responsive records from August 1, 2019, through the date the search is conducted.

Statement of Noncommercial Purpose

This request is made for noncommercial purposes. American Oversight seeks records regarding Senator Fann's affiliation with ALEC, a group that convenes state legislators to coordinate legislative priorities and solutions. ALEC's influence on lawmakers is a topic of substantial public interest.² Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent Arizona state legislators have been influenced in their official duties by ALEC or ALEC members.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.³

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying

and postage charges, if applicable.⁴ Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that have been withheld and the reasons the records or categories of records have been withheld.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.
