Re: Public Records Request

Dear Michael Boal:

Pursuant to the Iowa Public Records Law, Iowa Code, Ch. 22, American Oversight makes the following request for records.

On March 12, 2021, Iowa Senate Majority Leader Jack Whitver indicated that the state might sue the U.S. Census Bureau in an attempt to compel the release of block-level redistricting data in advance of the agency's projected September 30, 2021 deadline.¹ While Iowa has not filed suit, Ohio has reached an agreement with the Census Bureau to place its own suit on hold provided the agency releases data no later than August 16, 2021.² Alabama is pursuing parallel litigation objecting to the Census Bureau's implementation of a new data privacy technique, which the suit alleges has contributed to the delay in the release of redistricting data.³

American Oversight seeks records with the potential to shed light on the redistricting process in Iowa.

To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both a specified official's response to an email containing one of the listed key terms and the initial received message are responsive to this request and should be produced.

 To the extent that an email is responsive to our request, our request includes all
 prior messages sent or received in that email chain, as well as any attachments to
 the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted

using unofficial systems or stored outside of official files are subject to the Public Records Law.⁴

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your agency can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.
