**Re: Public Records Request**

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

The Arizona Senate's investigation into Maricopa County's ballots and election equipment has raised alarm regarding its partiality and the chosen contractors' lack of experience.<sup>1</sup> While the original scope of the investigation included in-person canvassing of voters, the Senate has at least temporarily suspended these plans in response to a letter from the Department of Justice expressing concerns of potential voter intimidation.<sup>2</sup> However, public reporting indicates that residents of Pima and Yavapai Counties have been contacted by individuals claiming to represent the County Recorder's or Sheriff's offices.<sup>3</sup>

American Oversight seeks records with the potential to shed light on in-person canvassing of voters in Arizona.

## Requested Records

American Oversight requests that your office promptly produce the following records:

- A. All electronic communications (including emails, email attachments, text messages, messages on messaging platforms, such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp) between (i) Supervisor Steve Christy and (ii) any of the individuals or entities listed below. In the case of emails and texts, the search should include those sent or received from Supervisor Christy's personal accounts and devices if they were used to conduct official business, as well those sent from his official email addresses or government-issued devices.

Please note that American Oversight does not seek, and that this request specifically excludes, the initial mailing of news clips or other mass-distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if Supervisor Christy received a mass-distribution news clip email from the Arizona Republican Party, that initial email would not be responsive to this request. However, if Supervisor Christy forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

- B. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) sent by Supervisor Steve Christy

containing any of the key terms listed below.

Please provide all responsive records from November 3, 2020, through the date the search is conducted.

In an effort to accommodate your agency and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited its request to emails sent by Supervisor Christy. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both Supervisory Christy's response to an email from one of the entities listed above and the initial received message are responsive to this request and should be produced.

**Statement of Noncommercial Purpose**

This request is made for noncommercial purposes. American Oversight seeks records regarding reported in-person canvassing of voters in Arizona.<sup>4</sup> Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether or to what extent county officials have been aware of these canvassing efforts or have communicated with organizers.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes

materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>5</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.<sup>6</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
