## Re: Public Records Law Request

Dear Representative Wichgers:

Pursuant to Wisconsin's public records law, Wis. Stat. §§ 19.31–19.39, American Oversight makes the following request for copies of records.

On May 26, 2021, Wisconsin State Assembly Speaker Robin Vos indicated that the legislature would hire three former law enforcement officers and a supervising attorney to investigate the November 2020 election. Since this announcement, the names of several of the contracted individuals have been made public—and include former Milwaukee Police Detective Mike Sandvick and former Wisconsin Supreme Court Justice Michael Gableman, whose past actions have raised concerns over the partiality of the investigation. In June, several Wisconsin state legislators, including Assembly Campaigns and Elections Committee chair Janel Brandtjen, visited the site of the Arizona State Senate's partisan "audit." Former President Trump, among others, has

criticized the Wisconsin Legislature for failing to pursue a "full forensic investigation" of the election.4

American Oversight seeks records with the potential to shed light on the legislature's investigation of the November 2020 election, including those regarding similar partisan reviews in other states and calls for Wisconsin to expand its investigation.

# Requested Records

American Oversight requests that your office produce the following records "as soon as practicable and without delay":<sup>5</sup>

Any handouts, agendas, summaries, or notes provided to or created by Representative Chuck Wichgers or any member of their staff as part of their trip to the site of the Arizona Senate's investigation into Maricopa County's elections taking place at the Veterans Memorial Coliseum in Phoenix, Arizona.<sup>6</sup> Responsive records would include, but not be limited to (A) electronic or hard-copy records provided to the representative by Voices & Votes or One America News, members or agents of the Arizona State Senate, or any formal or informal advisors or volunteers associated with the Senate's investigation at any point prior to, during, or following their tour of audit facilities, or (B) formal or informal notes, descriptions, or analyses of the Maricopa County investigation created by the representative or any member of their staff.

Please provide all responsive records from June 1, 2021, through June 30, 2021.

# **Fee Waiver Request**

In accordance with Wis. Stat. § 19.35(3)(e), American Oversight respectfully requests that the records be produced without charge. Providing American Oversight with a waiver of fees is in the "public interest" because American Oversight will, in accordance with its organizational mission, make the records available to the public without charge. These disclosures will likely contribute to a better understanding of relevant government procedures by the general public.

American Oversight's work is aimed solely at serving the public interest. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of

the information requested is not in American Oversight's financial interest. Rather, American Oversight's mission is to serve the public by promoting transparency in government, educating the public about government activities, and ensuring the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media.<sup>7</sup> American Oversight also makes materials it gathers available on its public website<sup>8</sup> and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>9</sup>

The public has a significant interest in the Wisconsin state legislature's delegation to the Arizona State Senate's investigation of Maricopa County's election results and administration. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether or to what extent partisan motivations or external actors guided the decision of Wisconsin lawmakers to investigate the state's own election or expand the current investigation. American Oversight is committed to transparency and makes the responses agencies provide to public records requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

American Oversight asks that if its request for a fee waiver is denied in whole or in part, that you contact us prior to incurring any costs.

## Guidance Regarding the Search & Processing of Requested Records

Please search all locations and systems likely to have responsive records regarding official business. You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts. Emails conducting government business sent or received on the personal account of the authority's officer or employee constitutes a record for purposes of Wisconsin's public records laws.<sup>11</sup>

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. <sup>12</sup> If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

American Oversight expects that you have ensured all responsive records and records relevant to this request and your compliance with it are retained as required by Wisconsin law. Please take all appropriate steps to ensure that no such records are deleted by the agency before the completion of processing for this request. If records potentially responsive or relevant to this request, or your compliance with it, are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
