### **Re: Public Information Request**

Dear Secretary Spaw:

Pursuant to the Texas Public Information Act, as codified at Tex. Code ch. 552, American Oversight makes the following request for public records.

## Requested Records

American Oversight requests that the Texas State Senate promptly produce the following:

1. A complete copy (including any attachments) of any contract, amendment, memorandum of understanding, or other written agreement regarding external entities providing services relevant to the state or congressional redistricting processes, including, but not limited to, agreements with providers of map drawing software, consultants, advisors, or legal counsel.

This request should be interpreted to include any copies of contractual documents pertaining to redistricting in possession of the Texas State Senate, the Senate Special Committee on Redistricting, or Senator Joan Huffman's office, including those to which the Texas State Senate, the Senate Special Committee on Redistricting, or Senator Huffman are not party.

For request item 1, please provide all responsive records from April 22, 2021, through the date the search is conducted.

2. A complete copy of any unpublished formal or informal guidance, directives, memoranda, criteria, or other policy document pertaining to redistricting issued by or in possession of the Senate Special Committee on Redistricting or Senator Huffman's office.

For request item 2, please provide all responsive records from April 22, 2021, through the date the search is conducted.



3. Any district boundary proposals produced by any member of the Senate Special Committee on Redistricting, any Senate Special Committee on Redistricting staff member, or any entity commissioned or contracted by the Senate Special Committee on Redistricting or the Texas State Senate, as well as any related data analyses. Please note that this request does not seek electoral district maps or community of interest maps submitted as public comment by members of the public.

For request item 3, please provide all responsive records from January 1, 2021, through the date the search is conducted.

4. Any records containing assessments, interpretations, or opinions concerning data from the 2020 Census or the 2020 American Community Survey (ACS).

For request item 4, please provide all responsive records from January 1, 2021, through the date the search is conducted.

5. Any records containing assessments, interpretations, or opinions concerning past election results.

For request item 5, please provide all responsive records from January 1, 2021, through the date the search is conducted.

6. Any records containing assessments, interpretations, or opinions concerning political party affiliation data, racial demographic data, or present incumbency.

For request item 6, please provide all responsive records from January 1, 2021, through the date the search is conducted.

7. Records sufficient to identify the redistricting-related roles or responsibilities of any member of the Senate Special Committee on Redistricting, any Senate Special Committee on Redistricting staff member, or any entity commissioned or contracted by the Senate Special Committee on Redistricting or the Texas State Senate for redistricting-related work.

For request item 7, please provide all responsive records from January 1, 2021, through the date the search is conducted.

8. Records reflecting any training materials used to instruct any member of the Senate Special Committee on Redistricting, any Senate Special Committee on Redistricting staff member, or any entity commissioned or contracted by the Senate Special Committee on Redistricting or the Texas State Senate for redistricting-related work, in their roles or responsibilities.

For request item 8, please provide all responsive records from January 1, 2021, through the date the search is conducted.

9. Any records containing any formal or informal appraisal of or comment on any content or public comment submitted to the Senate Special Committee on Redistricting by members of the public in possession of Senator Huffman's office.

For request item 9, please provide all responsive records from January 1, 2021, through the date the search is conducted.

Please provide all responsive records from January 1, 2021, through the date the search is conducted.

American Oversight seeks all responsive records regardless of format, medium, or physical characteristics. In conducting your search, please understand the term "record" in its broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions. Our request includes any attachments to these records. No category of material should be omitted from search, collection, and production.

In addition, American Oversight insists that your office use the most up-to-date technologies to search for responsive information and take steps to ensure that the most complete repositories of information are searched. American Oversight is available to work with you to craft appropriate search terms. However, custodian searches are still required; governmental authorities may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.

Please search all records regarding official business. You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts. Emails conducting government business sent or received on the personal account of a governmental authority's officer or employee constitutes a record for purposes of the Texas Public Information Act.<sup>1</sup>

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

Please take appropriate steps to ensure that records responsive to this request are not deleted by your office before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

To ensure that this request is properly construed, that searches are conducted in an adequate but efficient manner, and that extraneous costs are not incurred, American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your office can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in electronic format by email or in PDF or TIF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

# Fee Waiver Request

In accordance with Tex. Code § 552.267(a), American Oversight requests a waiver of fees associated with processing this request for records, because such a waiver "is in the public interest because providing the copy of the information primarily benefits the general public." The requested records are directly related to the work of state officials, with the potential to shed light on Texas' redistricting process. This matter is a subject of substantial public interest in Texas.<sup>2</sup> Accordingly, release of records that may help the public understand the operations and activities of state officials is in the public interest.

Release of the requested records will primarily benefit the public.<sup>3</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the requested records is not in American Oversight's financial interest, but is rather in the public interest. American Oversight is committed to transparency and makes the responses governmental authorities provide to public records requests publicly available. As noted, the subject of this request is a matter of public interest, and the public would benefit from an enhanced understanding of the government's activities through American Oversight's analysis and publication of these records. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes

materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>4</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.<sup>5</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the organization's investigations into misconduct and corruption in state governments;6 the posting of records related to the Trump Administration's contacts with Ukraine and analyses of those contacts; posting records and editorial content about the federal government's response to the Coronavirus pandemic;8 posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal; the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers; 10 and posting records and analysis of federal officials' use of taxpayer dollars to charter private aircraft or to use government planes for unofficial business.11
