**Re: Freedom of Information Act Request**

Dear FOIA Coordinator:

Pursuant to Michigan's Freedom of Information Act (FOIA), as codified at Mich. Comp. Laws Ann. § 15.231 et seq., American Oversight makes the following request for records.

Macomb County Clerk Anthony Forlini has indicated that he is looking into the November 2020 election in Macomb County, stating to local press, "I can't tell you whether it (2020 election) was hacked. I might be able to with more information."<sup>1</sup> As part of his investigation of elections in the county, Forlini has requested voting information from municipal clerks and requested phone records of local officials.<sup>2</sup> On October 5, Forlini announced that the review would be conducted by Pro V&V and would cost the county roughly \$16,000.<sup>3</sup>

American Oversight seeks records with the potential to shed light on apparent investigations into the November 2020 election in Macomb County, including whether or to what extent county officials are acting in coordination or communication with individuals or entities engaged in similar investigations in other jurisdictions.

**Requested Records**

American Oversight requests that your office respond to this request for the following records within five business days:

- A. Complete copies (including any attachments) of any proposal, statement of work, project plan, contract, subcontract, amendment, memorandum of understanding, invoice, or payment submitted to, created by, or in the possession of Macomb County, including but not limited to the County Clerk's office, or anyone serving as its liaison, agent, contractor, or intermediary, in connection with the planning, preparation, or execution, of any potential or actual audit, recount, investigation, or other analysis or review of the November 2020 election results in Macomb County.
- B. Complete copies (including any attachments) of any formal or informal guidance, directives, memoranda, or other policy and procedure documents issued to entities, departments, or individuals in connection with the planning, preparation, or execution, of any potential or actual audit, recount, investigation, or other analysis or review of the November 2020 election results in Macomb County, including but not limited to:
  - 1. Directives regarding the scope and duration of any investigations
  - 2. Records identifying, prioritizing, and investigating alleged fraud, misconduct, or irregularities
  - 3. Protocols for contacting persons of interest, including, but not limited, to guidelines or scripts for contacting and interviewing voters
  - 4. Guidance regarding the presentation of any findings
  - 5. Guidelines for ensuring the safe handling and privacy of confidential voter information and ballot equipment
  - 6. Any other directives regarding the planning, preparation, and execution of any investigations

For Parts A & B of this request, please provide all responsive records from June 1, 2021, through the date the search is conducted.

### **Fee Waiver Request**

In accordance with Mich. Comp. Laws Ann. § 15.234(2), American Oversight requests a waiver of fees associated with processing this request for records. A waiver of fees for this request “is in the public interest because searching for or furnishing copies of the public record[s] can be considered as primarily benefiting the general public.”<sup>4</sup>

The public has a significant interest in elections in Michigan, including efforts by state and local officials to investigate elections results.<sup>5</sup> Records with the potential to shed light on this matter will help American Oversight and the general public understand whether or to what extent Macomb County officials may have acted in communication

or coordination with individuals or entities engaged in similar investigations in other jurisdictions.

American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the general public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>6</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.<sup>7</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the organization's investigations into misconduct and corruption in state governments;<sup>8</sup> an ethics waiver received by a senior U.S. Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;<sup>9</sup> posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the federal administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>10</sup> posting records regarding potential self-dealing at the U.S. Department of Housing & Urban Development and related analysis;<sup>11</sup> posting records and analysis relating to the federal government's efforts to

sell nuclear technology to Saudi Arabia;<sup>12</sup> and posting records and analysis regarding the U.S. Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.<sup>13</sup>

Finally, this request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest.

Accordingly, American Oversight qualifies for a fee waiver.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.<sup>14</sup> If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

### **Conclusion**

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request.
