### **Re: Freedom of Information Act Request**

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, 6 C.F.R. Part 5 and 19 C.F.R § 103.2, American Oversight makes the following request for records.

### **Requested Records**

American Oversight requests that U.S. Customs and Border Protection (CBP) produce the following records within twenty business days:

All muster documents and memoranda produced and distributed by the CBP Office of Field Operations, or any other responsible offices, to CBP Field Operations Directors and CBP Field Offices.

Please provide all responsive records from January 20, 2021, through the date the search is conducted. An example of a weekly muster document is included as Exhibit A to aid in your search.

### Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."<sup>1</sup> The public has a

significant interest in documents detailing the operations and policy procedures of U.S. Customs and Border Protection field offices in light of CBP arrests along the U.S.-Mexico border reaching their highest total ever recorded.<sup>2</sup> Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including how CBP is managing officer conduct and logistics at field offices across the country during a period of record-level border arrests. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.<sup>3</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>4</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.<sup>5</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the Trump Administration's contacts with Ukraine and analyses of those contacts;<sup>6</sup> posting records and editorial content about the federal government's response to the Coronavirus pandemic;<sup>7</sup> posting records received as part of American Oversight's

"Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>8</sup> the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;<sup>9</sup> and posting records and analysis of federal officials' use of taxpayer dollars to charter private aircraft or use government planes for unofficial business.<sup>10</sup>

Accordingly, American Oversight qualifies for a fee waiver.

### Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in

files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.<sup>11</sup> It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.<sup>12</sup>

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,<sup>13</sup> and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

Message:	The Role of Social Media in Public Trust and Perception

Recently some posts on social media have portrayed the Office of Field Operations (OFO) in a negative light. These posts have shown OFO marked government owned vehicles (GOVs), parked at local businesses. Accusations were made on social media that Customs and Border Protection (CBP) employees were failing to promote the mission effectively and were abusing the public trust.

In one instance, it was alleged that a CBP detector dog was left unattended in a GOV at a local restaurant in extreme heat. These types of allegations hurt our public perception and damage public trust. Additionally, if these allegations are factual, the actions of the CBP employee could be a violation of established policy, and most importantly cause harm to a valuable CBP resource, our canine partners.

In fulfilling its mission, CBP and its employees must sustain the trust and confidence of the public they serve. All employees must maintain high standards of honesty, integrity, impartiality, character, and professionalism to ensure the proper performance of government business and the continued trust and confidence of the public.

Furthermore, employees will not use, or authorize the use of, a GOV except for official purposes, i.e., those deemed essential to the successful completion of the official mission. Willful use of a GOV for other than official purposes carries a minimum statutory penalty of a 30-day suspension from duty and pay.

Please use extreme discretion and professionalism when representing CBP throughout the community. Remember that almost everyone has a camera on their phone, and social media is a powerful tool that can be used in an instant to damage the public trust, whether the allegation is based in fact or just a misperception. Also, all Canine Enforcement Program (CEP) employees are reminded that adherence to national and local canine transportation and heat related safety policies are clearly documented and will be enforced.

Finally, be mindful that every CBP employee has the responsibility to act in a manner that is professional and beyond reproach. We must never fail to deliver the core values of vigilance, service and integrity.
