**Re: Public Records Request**

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

On October 6, 2021, public officials from several states, including Arizona, participated in a “Ballot Integrity Summit” in Dallas, Texas, which included a tour of the facilities of anti-counterfeiting technology company Authentix.<sup>1</sup> Representative Mark Finchem, who attended the summit, previously displayed an Authentix ballot at the state capitol and has indicated he intends to seek a legal requirement for Arizona’s ballots to contain security features like those on Authentix ballots.<sup>2</sup>

American Oversight seeks records with the potential to shed light on the activities of Arizona officials with respect to “ballot integrity” efforts, including, but not limited to records regarding the October 6 conference and communications with other attendees and Authentix.

**Requested Records**

American Oversight requests that your office promptly produce the following records:

All electronic communications (including emails, email attachments, text messages, or messages on messaging platforms, such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp) between (i) Representative Leo Biasucci and (ii) any of the individuals or entities below, including, but not limited to at

the suggested email addresses or domains. The search should include those sent or received from personal accounts and devices if they were used to conduct official business, as well those sent or received from any official email addresses or government-issued devices.

**Specified Individuals or Entities:**

1. Kent Mansfield, or anyone communicating on behalf of Authentix (including anyone communicating from an email address ending in @authentix.com)
2. Michigan Secretary of State Candidate Kristina Karamo
3. Nevada Secretary of State Candidate Jim Marchant
4. U.S. Representative Jody Hice
5. Wisconsin Representative Dave Murphy
6. Wisconsin Representative Amy Loudenbeck
7. Wisconsin Secretary of State candidate Jay Schroeder
8. Cochise County Recorder David Stevens

Please note that American Oversight does not seek, and that this request specifically excludes the initial mailing of news clips or other mass-distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if Rep. Biasucci received a mass-distribution news clip email from someone communicating on behalf of Authentix, that initial email would not be responsive to this request. However, if Rep. Biasucci forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

Please provide all responsive records from November 3, 2020, through the date the search is conducted.

**Statement of Noncommercial Purpose**

This request is made for noncommercial purposes. American Oversight seeks records regarding the administration of elections in Arizona. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including regarding the nature of the October 6 “Ballot Integrity Summit” and communications between Arizona officials and other summit attendees or representatives of Authentix.<sup>3</sup>

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight’s financial interest and is not made for a commercial purpose. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes

materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>4</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.<sup>5</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that have been withheld and the reasons the records or categories of records have been withheld.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
