## Re: Virginia Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Virginia Freedom of Information Act, Va. Code Ann. § 2.2-3700, I, Austin Evers, a resident of Virginia, make the following request for records.

Virginia State Senator Amanda Chase has repeatedly denied the validity of the November 2020 election and in 2020 called for former President Trump to declare martial law to prevent its certification. In the following year, Sen. Chase participated in further efforts to cast doubt on the election, including visiting the site of the Arizona Senate's widely discredited "audit" of Maricopa County's election results and attending election conspiracist and MyPillow CEO Mike Lindell's "Cyber Symposium" in Sioux Falls, South Dakota. South Dakota.

American Oversight seeks records with the potential to shed light on efforts to undermine faith in American elections, including records showing whether and to what extent Sen. Chase participated in these efforts.

### **Requested Records**

I request that your office produce the following records within five working days:

- 2. Any "Election Integrity Call," "2020 Election Remediation" meetings,<sup>5</sup> or other election related events or meetings organized or attended by Ivan Raiklin and/or Al Hartman
- 3. The "Cyber Symposium" organized by Mike Lindell, held in Sioux Falls, South Dakota from August 8-11, 2021<sup>6</sup>
- 4. Any conference call on election integrity<sup>7</sup> organized by Sen. Chase or her staff
- 5. The September 1 "Justice for January 6" rally held at the Arizona State Capitol<sup>8</sup>
- 6. Sen. Chase's briefing to the office of Virginia State Senate Minority Leader Tommy Norment prior to the November 2 elections<sup>9</sup>

In connection with its request for records, I provide the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. I seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- My request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to this request, this request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to me, please do not hesitate to reach out to my contact listed below to discuss this request. We welcome an opportunity to discuss this request with you before you undertake your search or incur search or duplication costs. By working together at the outset, we can decrease the likelihood of costly and time-consuming litigation in the future.

Alternatively, please provide responsive material in native format or in PDF format on a USB drive. If it will accelerate release of responsive records, please also provide responsive material on a rolling basis.

**Set Up.** After you accept this invite, we will send you an invitation to download the Wickr Pro calling app and join our MEETING ROOM. Please complete this step BEFORE the call begins as it does take time. For a test run in the app or for questions, please email jlimcher@hi-reit.com or text (713) 819-9872. We are glad to assist with registration and have tech support lined up to resolve issues.

**Starting Call on Saturday.** Once the call starts at 2:00 PM CST, open the Wickr Pro app and click the green JOIN button to enter the Meeting Room. If you lose connection during the call, open the app and again click the green JOIN button.
