## Re: Public Records Request

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

# Requested Records

American Oversight requests that the Arizona Senate promptly produce the following records:

All email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) and text messages or messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, Twitter direct messages, Facebook messages, WhatsApp, Signal, Telegram, or Parler) between (a) Senator Kelly Townsend or anyone communicating on her behalf, such as her aide KayRee Kubat, and (b) any of the following external parties, including, but not limited to, communications from the email addresses or email addresses ending in the domains specified below.

Please note that American Oversight does not seek, and that this request specifically <u>excludes</u>, the <u>initial</u> mailing of news clips or other mass distribution emails. However, subsequent communications forwarding such emails <u>are</u> responsive to this request. In other words, for example, if Senator Townsend



received a mass-distribution news clip email from one of the specified entities, that initial email would <u>not</u> be responsive to this request. However, if Senator Townsend forwarded that email to another individual with her own commentary, that subsequent message would be responsive to this request and should be produced.

Please provide all responsive records from January 1, 2022, through the date the search is conducted.

## Statement of Noncommercial Purpose

This request is made for noncommercial purposes. American Oversight seeks records regarding the lawsuit to end early voting in Arizona. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent Senator Townsend was involved in challenges to Arizona's early voting laws.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>2</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying

and postage charges, if applicable.<sup>3</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

## Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Our request for records includes any attachments to those records or other
  materials enclosed with those records when they were previously transmitted.
  To the extent that an email is responsive to our request, our request includes all
  prior messages sent or received in that email chain, as well as any attachments to
  the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that have been withheld and the reasons the records or categories of records have been withheld.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
