Re: Public Records Law Request

Dear Records Custodian:

Pursuant to the Louisiana Public Records Law, La. Rev. Stat. Ann. 44:1 *et seq.*, American Oversight makes the following request for records.

On December 14, 2021, the Louisiana Voting Systems Commission held a meeting attended by Secretary of State Kyle Ardoin. Among the speakers at the meeting were Phil Waldron—who collaborated with associates of former President Trump to attempt to prevent the certification of the November 2020 presidential election—and Draza Smith—a Colorado-based election conspiracy theorist with ties to Mike Lindell.¹

American Oversight seeks records with the potential to shed light on this meeting, including whether or to what extent officials in the Office of the Secretary of State have communicated with individuals who have sought to overturn or cast doubt on the November 2020 presidential election.

Requested Records

American Oversight requests that your office produce the following records within three business days:

1. All records reflecting communications (including emails, email attachments, text messages, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), telephone call logs, calendar invitations, calendar entries, meeting notices, meeting agendas, informational

material, talking points, any handwritten or electronic notes taken during any oral communications, summaries of any oral communications, or other materials) sent or received by the officials in the Office of the Secretary of State of Louisiana, specified below, regarding the December 14, 2021 meeting of the Louisiana Voting System Commission.

Responsive records should be interpreted to include, but not be limited to, records reflecting communications with members of the Voting System Commission or anyone communicating on the commission's behalf, with organizers or attendees of the meeting, or with other individuals or entities regarding the content of the meeting.

In the case of emails and texts, the search should include those sent or received from the specified officials' personal accounts and/or devices if they were used to conduct official business, as well as those sent from their official email addresses or government-issued devices.

2. All records reflecting communications (including emails, email attachments, text messages, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), telephone call logs, calendar invitations, calendar entries, meeting notices, meeting agendas, informational material, talking points, any handwritten or electronic notes taken during any oral communications, summaries of any oral communications, or other materials) between the officials in the Office of the Secretary of State listed above in Part 1, and (a) Phil Waldron (including, but not limited to, from the email address phil@onewarrior.com or any communications from an email address ending in @bonfiresearch.org), or (b) Draza Smith (including, but not limited to, from the email addresses drazasmith@gmail.com or drazasmith@protonmail.com).
3. Any handouts, agendas, summaries, or notes provided in connection with the December 14, 2021 meeting of the Louisiana Voting System Commission, including, but not limited to: (a) electronic or hard-copy records provided by attendees, participants, or organizers of the commission meeting, or (b) formal or informal notes, descriptions, or analyses of the event created by the officials listed below.

For each item of this request, please provide all responsive records from November 14, 2021, through December 31, 2021.

Fee Waiver Request

In accordance with La. Rev. Stat. Ann. 44:32(C)(2), American Oversight requests a waiver of fees associated with processing this request for records. A waiver of fees for this request is appropriate, because American Oversight's use of the requested records "will be limited to a public purpose."

This request is made solely for a public purpose. The public has a significant interest in the administration of elections in Louisiana. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including the extent to which elections officials in Louisiana have been in contact with individuals or entities seeking to undermine public confidence in elections.² American Oversight is committed to transparency and makes the responses agencies provide to public records requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

Furthermore, this request is fundamentally made for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.³

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.⁴ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization's investigations into misconduct and corruption in state governments;⁵ posting records and analysis of federal and state governments'

responses to the Coronavirus pandemic;⁶ posting records received as part of American Oversight’s “Audit the Wall” project to gather and analyze information related to the Trump administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁷ and the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department’s process for issuing such waivers.⁸

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as

personal email accounts or text messages. Public business communications conducted on private email accounts and devices are public records subject to the Public Records Law.⁹

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

Conclusion

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request.
