**Re: Mississippi Public Records Act Request**

Dear Public Records Officer:

Pursuant to the Mississippi Public Records Act, Miss. Code § 25-61-1 et seq., American Oversight makes the following request for records.

**Requested Records**

American Oversight requests that your office produce the following records within seven working days:

1. All email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) and text messages or messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, Twitter direct messages, Facebook messages, WhatsApp, Signal, Telegram, or Parler) between:
  - (a) any of the officials listed below, and
  - (b) Graham Ledger ([grahamledger@yahoo.com](mailto:grahamledger@yahoo.com)), or Christina Bobb ([christina.bobb@protonmail.com](mailto:christina.bobb@protonmail.com), [christina@cbgstrategies.com](mailto:christina@cbgstrategies.com)), or anyone communicating on behalf of One America News Network, including anyone communicating from [therealstoryoan@gmail.com](mailto:therealstoryoan@gmail.com) or an email address ending in @oann.com.

Officials:

- i. Attorney General Lynn Fitch, or anyone communicating on her behalf, such as an assistant or scheduler
- ii. Chief of Staff Michelle Williams
- iii. Deputy for Administrative Operations Jesse Graham
- iv. Anyone acting as Communications Director or Press Secretary for the Office of the Attorney General

For request item 1, please provide all responsive records from June 1, 2021, through the date the search is conducted.



Please note that American Oversight does not seek, and that item 1 of this request specifically excludes, the initial mailing of news clips or other mass distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if Attorney General Fitch received a mass-distribution news clip email from one of the specified entities, that initial email would not be responsive to this request. However, if Attorney General Fitch forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

2. All email communications and text messages or messages on messaging platforms (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments, text messages, text message attachments, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, Twitter direct messages, Facebook messages, WhatsApp, Signal, Telegram, or Parler) sent by any of the officials listed above containing any of the following key terms:

Key Terms:

- a. "One America News"
- b. OAN
- c. OANN
- d. DirecTV
- e. AT&T
- f. Morrow
- g. "Bill Morrow"
- h. "Herring Networks"

For request item 2, please provide all responsive records from January 14, 2022, through the date the search is conducted.

In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited request item 2 to emails, text messages, or electronic messages sent by the specified officials. To be clear, however, American Oversight still requests that complete email chains and text or electronic message threads be produced, displaying both sent and received messages. This means, for example, that both Attorney General Fitch's response to an email containing one of the listed key terms and the initial received message are responsive to this request and should be produced.

Please note that American Oversight does not seek, and that part 2 of this request specifically excludes, responsive records to the extent that a key term only appears in a news clip or news story.

Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fee.

## **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your agency can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

### **Conclusion**
