Re: Freedom of Information Act Request

Dear Chief Carr:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Department of Defense (DoD), American Oversight makes the following request for records.

On January 6, 2021, then-President Trump incited a mob to attack Congress while members were meeting to certify the election for then-President-elect Joe Biden. The insurrectionists attacked the Capitol, forced their way past understaffed Capitol Police, and ultimately delayed the Congressional session as the mob forced lawmakers and their staffs to flee. During this assault, five people died.

While militia members roamed congressional halls, Trump reportedly fought against deploying the D.C. National Guard,⁴ and the Defense Department reportedly initially denied a request, before later reversing the decision.⁵ Congress was able to certify the

win for Biden only later in the evening after Capitol Police, the Federal Bureau of Investigation (FBI), the National Guard, Metropolitan Police Department (MPD), and other law enforcement officials reclaimed the Capitol.⁶

American Oversight seeks records reflecting the roles that senior officials played during this attack on American democracy and the peaceful transfer of power.

Requested Records

American Oversight requests that the Department of Defense produce the following records within twenty business days:

All records reflecting communications (including emails, email attachments, complete email chains, text messages (or messages on similar applications such as Signal or WhatsApp), calendar invitations, and notes or readouts from phone calls) between (1) Chairman of the Joint Chiefs of Staff Mark Milley or anyone communicating on his behalf such as a Chief of Staff, scheduler, or assistant, and (2) Vice President Mike Pence or Marc Short, Chief of Staff to Vice President Mike Pence, or anyone communicating on either of their behalf (including, but not limited to, anyone communicating with email addresses ending in ovp.eop.gov).

Please provide all responsive records from January 6, 2021, through January 7, 2021.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government." The public has a significant interest in any communications between Chairman Milley and Vice

President Pence on January 6, 2021.8 Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including who was commanding U.S. troops on January 6, 2021 as an insurrection attempt unfolded at the U.S. Capitol. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter. Oversight as a facebook and Twitter.

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.¹¹ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the Trump Administration's contacts with Ukraine and analyses of those contacts;¹² posting records and editorial content about the federal government's response to the Coronavirus pandemic;¹³ posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and

analyses of what those records reveal;¹⁴ the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;¹⁵ and posting records and analysis of federal officials' use of taxpayer dollars to charter private aircraft or use government planes for unofficial business.¹⁶

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as

personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.¹⁷ It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.¹⁸

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically, 19 and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
