Re: Virginia Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the Virginia Freedom of Information Act, Va. Code Ann. § 2.2-3700, I, Heather Sawyer, a resident of Virginia, make the following request for records.

Requested Records

I request that your office produce the following records within five working days:

1. All communications between or among (a) one or more employees who work within the Virginia Governor's Office and (b) any group or individual outside the government of Virginia, that are related to the creation or operation of the helpeducation@governor.virginia.gov email account (referred to throughout as the "Tip Line").
2. To the extent not encompassed by the foregoing: All documents provided (or made accessible) to any group or individual outside the government of Virginia, by an employee or employees who work within the Virginia Governor's Office, related to the creation or operation of the Tip Line, including, but not limited to, instructions, protocols, or other information regarding the creation, operation, organization or administration of the Tip Line; information compiled from any collected tips; and the product of any review or investigation of tips received through the Tip Line.
3. All communications between or among (a) one or more employees who work within the Virginia Governor's Office and (b) an employee or employees of the Commonwealth or its municipalities or subdivisions, who work outside the Office of the Governor, that are related to the creation or operation of the Tip Line. As used here, "employees of the Commonwealth or its municipalities or subdivisions," includes, but is not limited to, employees of the Virginia Department of Education and employees or other representatives of Virginia's public school districts and school boards.

4. To the extent not encompassed by the foregoing: all documents provided (or made accessible) to an employee or employees of the Commonwealth or its municipalities or subdivisions, who work outside the Office of the Governor, by an employee or employees who work within the Virginia Governor's Office, related to the creation or operation of the Tip Line, including, but not limited to, instructions, protocols, or other information regarding the creation, operation, organization, or administration of the Tip Line; information compiled from any collected tips; and the product of any review or investigation of tips received through the Tip Line. As used here, "employees of the Commonwealth or its municipalities or subdivisions," includes, but is not limited to, employees of the Virginia Department of Education and employees or other representatives of Virginia's public school districts and school boards.

Please provide all responsive records from January 15, 2022, through the date the search is conducted.

Please notify me of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fee.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, I provide the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. I seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- My request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to this request, this request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to me, please do not hesitate to reach out to my representative at the contact information listed below to discuss this request. We welcome an opportunity to discuss this request with you before you undertake your search or incur search or duplication costs. By working together at the outset, we can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email to the address listed below. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records, please also provide responsive material on a rolling basis.
