### Re: Public Records Request

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

# Requested Records

American Oversight requests that the Arizona State Senate promptly produce the following records:

1. All records reflecting bills, expenses, and payment records related to the Senate's audit of the 2020 election in Maricopa County or related to additional or supplementary investigations or reports about the integrity of the 2020 election authorized or initiated by the Arizona State Senate.<sup>1</sup>

For part 1 of this request, please provide all responsive records from September 15, 2021, through the date the search is conducted.

2. All records reflecting bills, billing statements, expenses, and payment records to attorneys representing or consulting for the Arizona State Senate with respect to litigation related to the Senate's audit of the 2020 election in Maricopa County.

For part 2 of this request, please provide all responsive records from April 1, 2021, through the date the search is conducted.

# Statement of Noncommercial Purpose

This request is made for noncommercial purposes. American Oversight seeks records regarding the cost to taxpayers of the Arizona State Senate's audit of the 2020 election in Maricopa County. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including what the ongoing cost of the audit is.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>2</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.<sup>3</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

## Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
