**Re: Sunshine Law Request** 

Dear Custodian of Records:

Pursuant to the Missouri Sunshine Law, Mo. Rev. Stat. § 610.010 et seq., American Oversight makes the following request for records.

# Requested Records

American Oversight requests that the Office of the Secretary of State produce copies of the following records within three business days:

- 1. Any handouts, presentation materials, summaries, or notes (electronic or handwritten) provided to or created by the Office of the Secretary of State John Ashcroft as part of or in relation to the April 12–13, 2022 Secretaries of State Conference hosted by the Heritage Foundation and Honest Election Project in Washington, DC.<sup>1</sup>
- 2. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) <u>sent or received</u> by Secretary of State John Ashcroft, or anyone communicating on his behalf (such as an assistant or scheduler), containing the terms "Heritage," "Honest Elections," "HEP," or "Snead".
- 3. All text messages and messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Signal, Telegram, Skype, or WhatsApp) between Secretary of State Ashcroft and Jason Torchinsky.
- 4. All calendar entries and telephone call logs reflecting any meetings, calls, or conferences between Secretary of State John Ashcroft and Jason Torchinsky.

5. Any handwritten or electronic notes taken during any oral communications or summaries of any oral communications between Secretary of State John Ashcroft and Jason Torchinsky.

For all parts of this request, please provide all responsive records from March 1, 2022, through May 1, 2022.

## Fee Waiver Request

In accordance with Mo. Rev. Stat. § 610.026.1(1), American Oversight requests a waiver of fees associated with processing this request for records. Disclosure of the requested records is in the public interest because it will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information "is likely to contribute significantly to public understanding of the operations or activities of [a] public governmental body." The public has a significant interest in efforts regarding the administration of elections in Missouri. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent public officials have discussed election administration policies and practices with outside parties.

This request is primarily and fundamentally for non-commercial purposes.<sup>4</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>5</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses

posted to its website.<sup>6</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization's investigations into misconduct and corruption in state governments;<sup>7</sup> posting records and analysis of federal and state governments' responses to the Coronavirus pandemic;<sup>8</sup> posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the Trump administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>9</sup> and the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers.<sup>10</sup>

Accordingly, American Oversight qualifies for a fee waiver.

### Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.<sup>11</sup>
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted.
  To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. ¹² If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

### **Conclusion**

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more
