### **Re: Public Records Request**

Dear Public Records Officers:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

#### **Requested Records**

American Oversight requests that the Cochise County Recorder promptly produce the following records:

- 1. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) and text messages or messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, Twitter direct messages, Facebook Messenger, WhatsApp, Signal, Telegram, or Parler) between (a) Cochise County Recorder David Stevens, and (b) Cochise County Supervisors Tom Crosby or Peggy Judd, or La Paz County Elections Director Bob Bartelsmeyer.
- 2. Records reflecting any final formal or informal directives, guidance, assessments, reports, analyses, or recommendations concerning Cochise County elections or the County Recorder's responsibilities or powers authored, edited, issued, ordered, or approved by Cochise County Recorder David Stevens.
- 3. A complete copy (including any attachments) of any contract or subcontract, amendment, memorandum of understanding, or other written agreement



- authored, edited, issued, ordered, approved, or signed by any personnel within the Cochise County Recorder's Office or the Cochise County Elections Department (including, but not limited to, County Recorder David Stevens).
- 4. Records sufficient to identify all employees who have entered into any position in the Cochise County Recorder's Office or the Cochise County Elections Department since February 28, 2023. To the extent that such individuals have held multiple titles or positions since February 28, 2023, please produce records sufficient to identify each title or position.
- 5. For each individual identified in response to Part 4 of this request, any resumes or curriculum vitae (CV) submitted by that individual.
- 6. Records sufficient to identify the actual or prospective 2023-2024 fiscal year budgets for the Cochise County Recorder's Office and the Cochise County Elections Department.
- 7. Records sufficient to identify any alterations or proposed alterations to any budget for the Cochise County Recorder's Office or the Cochise County Elections Department authored, edited, issued, ordered, or approved by Cochise County Recorder David Stevens.
- 8. Records sufficient to identify all invoices from and payments to entities for services related to Cochise County's election administration.
- 9. Records sufficient to identify all costs and expenses incurred by the Cochise County Recorder's Office or the Cochise County Elections Department.

For all parts of this request, please provide all responsive records from February 28, 2023, through the date the search is conducted.

#### **Statement of Noncommercial Purpose**

This request is made for noncommercial purposes. American Oversight seeks records regarding efforts to alter Cochise County's election processes. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent Recorder David Stevens has reformed Cochise County's elections.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials.
