Re: Alabama Open Records Act Request

Dear Records Custodian:

Pursuant to the Alabama Open Records Act, Ala. Code § 36-12-40, the Southern Poverty Law Center (SPLC) makes the following request for records. SPLC is a citizen of Alabama that maintains its offices at 400 Washington Ave., Montgomery, Alabama 36104.

In January 2023, Secretary of State Wes Allen announced that Alabama would be withdrawing from the Electronic Registration Information Center (ERIC), a datasharing partnership among states that helps state participants with voter roll maintenance. SPLC seeks records to understand this decision.

Requested Records

SPLC requests that the Secretary of State's office promptly produce the following records:

- 1. Records reflecting any final formal or informal directives or guidance concerning any of the following matters:
 - a. the decision to withdraw Alabama from the Electronic Registration Information Center (ERIC);
 - b. any amendments or alterations to the bylaws or membership agreement of ERIC;
 - c. voter roll list maintenance;

- d. inactive and/or disqualified voters;
- e. notifying eligible but unregistered voters of their eligibility;
- f. any replacement system/s intended to serve the same function as ERIC membership.
- 2. All final assessments, reports, analyses, or recommendations in your possession (including formal memoranda and other written products) prepared by your office or otherwise provided to your office by other state or local offices, or independent experts, regarding any projected or actual impacts of withdrawing from the Electronic Registration Information Center.

For request items 1 and 2, please provide all responsive records from January 16, 2023, through the date the search is conducted.

3. All calendars or calendar entries for Secretary of State Wes Allen and Elections Director Jeff Elrod, including any calendars maintained on their behalf from January 16, 2023, through April 30, 2023.

Please notify SPLC of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fee.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, SPLC provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind,² such as electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in

files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
