Re: West Virginia Freedom of Information Act Request

Dear Records Custodian:

Pursuant to the West Virginia Freedom of Information Act, W. Va. Code § 29B-1-1 et seq., and Section 8 of the National Voter Registration Act of 1993 (NVRA), American Oversight makes the following request for copies of records.

Requested Records

American Oversight requests that the West Virginia Secretary of State produce the following records within five business days:¹

- 1. Any requests for proposals prepared by the West Virginia Secretary of State seeking vendors for cross-state voter data sharing programs or systems intended to serve as an alternative or replacement to Electronic Registration Information Center (ERIC) membership.
- 2. A complete copy of any proposals received by the West Virginia Secretary of State from vendors for cross-state voter data sharing programs or systems intended to serve as an alternative or replacement to ERIC membership.
- 3. A complete copy (including any attachments) of any contract or subcontract, amendment, memorandum of understanding, or other written agreement between the West Virginia Secretary of State and any external entities concerning cross-state voter data sharing programs or systems intended to replace ERIC membership.
- 4. Records reflecting any projected or actual costs of alternate cross-state voter data programs or sharing systems intended to replace ERIC membership.

5. A complete copy of any invoice from or payment to the United States Postal Service (USPS), National Change of Address (NCOA), Social Security Administration (SSA), or any other external entity regarding data use for cross-state voter data sharing.

Records responsive to part 5 of this request should include, but are not limited to invoices or payments for non-ERIC lists, reports, spreadsheets, or other forms of aggregated data used for purposes of ensuring the accuracy and currency of official lists of eligible voters as required by the National Voter Registration Act of 1993 (NVRA).²

For all parts of this request, please provide all responsive records from January 1, 2023, through the date the search is conducted.

Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the term "record" in its broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted.
 To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business.⁴ Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.⁵ If a request is denied in whole, please state specifically whether it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your office can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Conclusion

American Oversight is a 501(c)(3) nonprofit with the mission to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public
