Re: Arkansas Freedom of Information Act Request

Dear Custodian of Records:

Pursuant to the Arkansas Freedom of Information Act of 1967, Ark. Code § 25-19-101, I, a citizen of Arkansas, make the following request for records:

Requested Records

I request that the Arkansas Department of Education (ADE) produce the following records within three (3) business days, pursuant to Ark. Code § 25-19-105(e):

All email communications (including email messages, complete email chains, calendar invitations, and any attachments thereto) <u>between</u> (a) any of the ADE officials listed below—or anyone communicating on their behalf, such as an assistant or secretary—<u>and</u> (b) anyone communicating on behalf of Cornerstone Christian Academy, including, but not limited to, anyone communicating from an email address ending in ccawarriors.net.

- b. Chief of Staff Courtney Salas-Ford
- c. Deputy Commissioner Stacy Smith
- d. Assistant Commissioner of School Choice and Parent Empowerment Darrell Smith

Please provide all responsive records from October 15, 2023, through the date the search is conducted.

Fee Waiver Request

In accordance with Ark. Code Ann. § 25-19-105, I request a waiver of fees associated with processing this request for records. Disclosure of the requested records is in the public interest because it will likely contribute to a better understanding of relevant

government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

I request a waiver of fees because disclosure of the requested information is in the public interest.¹ The public has a significant interest in the decision by ADE officials to release a video promoting a private religious school.² Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including how and to what extent ADE officials communicated with the private school. I am committed to transparency and intend to make records provided in response to this Arkansas FOIA request publicly available, and the public's understanding of the government's activities would be enhanced through publication of these records.

This request is primarily and fundamentally for noncommercial purposes. I am a resident of Arkansas who cares about public education and our local schools, and my request for these records has no commercial purpose.

Accordingly, I qualify for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with my request for records, I provide the following guidance regarding the scope of the records sought and the search and processing of records:

- My request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, my request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency or specified individuals before the completion of

If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
